- a GST update -

Since the implementation of this tax structure, we noted that many GST registered businesses have overlooked the finer details of the GST law. The annual report highlighted by IRAS has shown an upward trend of non compliance and mistakes made in the submission of GST returns, i.e. 2008/09 IRAS reaped additional revenues of \$103.1 million in the last financial year.
